At the November 10, 2015 meeting, City Council approved the Bank of the West banking services agreement and authorized staff to execute documents to secure banking services.

Attached is the Resolution required to give the City Manager and the Finance Director the authority to enter into and manage investment and bank agreements, establish accounts, sign signature cards and execute other investment and bank related documents. The Resolution also designates the authorized signers for city warrants and provides a certificate of incumbency.
