

Complaint Process and Form

How do I file a complaint?

Any person may make a complaint concerning the conduct of a police department employee by speaking with a supervisor. Some community members' concerns may be minor and can be addressed by a supervisor informally. Concerns or complaints of a more severe nature will warrant a formal investigation. A person may initiate an official investigation in-person, over the telephone, via the police department web site by filling out this form and delivering it to the Sierra Madre Police Department, or by mailing a copy of the complaint to:

What happens next?

Once the Department receives a formal complaint, it will be assigned to an investigation. A thorough investigation will be conducted and will many times include an interview of the person making the complaint to obtain all relevant information. The investigation will involve interviewing those individuals who may be witnesses to the incident and the collection of evidence when appropriate.

If it is determined that the employee's conduct was criminal in nature, the case will be forwarded to the District Attorney's Office for consideration on filing criminal charges. If it is determined that the employee's conduct was a violation of department policy, they will receive discipline through the department's disciplinary procedures. If it is determined that the employee's conduct was appropriate, based on the circumstances, no disciplinary action will be taken.



Procedure for filing a complaint against a peace officer

YOU HAVE THE RIGHT TO MAKE A COMPLAINT AGAINST A POLICE OFFICER FOR ANY IMPROPER POLICE CONDUCT. CALIFORNIA LAW REQUIRES THIS AGENCY TO HAVE A PROCEDURE TO INVESTIGATE CIVILIANS' COMPLAINTS. YOU HAVE A RIGHT TO A WRITTEN DESCRIPTION OF THIS PROCEDURE. THIS AGENCY MAY FIND AFTER INVESTIGATION THAT THERE IS NOT ENOUGH EVIDENCE TO WARRANT ACTION ON YOUR COMPLAINT; EVEN IF THAT IS THE CASE, YOU HAVE THE RIGHT TO MAKE THE COMPLAINT AND HAVE IT INVESTIGATED IF YOU BELIEVE AN OFFICER BEHAVED IMPROPERLY. CIVILIAN COMPLAINTS AND ANY REPORTS OR FINDINGS RELATING TO COMPLAINTS MUST BE RETAINED BY THIS AGENCY FOR AT LEAST FIVE YEARS.
